

MUSKOGEE YOUTH FOOTBALL AND CHEER

Meeting Minutes
Sunday, June 6th 2010

Opening:

The regular meeting of the MYFC was called to order at 2:03 pm on 06/06/2010 at Muskogee Community hospitals' conference room.

A. Treasurer's Report

1. Gina Hall- \$20,465.56 in the bank. This includes monies collected for cheerleading uniforms. The estimated cost to be disbursed for the cheer uniforms is close to \$10,000.00 with cheer costs being @ \$150.00 per cheerleader.
2. *Outstanding Balances*- Fees collected should total \$41,450.00, of this amount 18,403.50 is still outstanding. **No outstanding balances for league.**
3. *Participants*- Currently registered for Cheer 86, Football 194. Total of 280.

B. Uniforms

1. Kim to email Dan with exact number of Uniforms to be ordered.
2. Boyd briefly discussed the problem of trying to fit kids who registered online.
3. *Recovery of uniforms*- Approximately 40 sets out, Brent to make a spreadsheet with all kids names who have uniforms still out to compare against kids trying to take new uniforms.
4. *Penny Jersey's*- Discussed purchasing 2 boxes of white, mesh, penny jersey's to have available when same grade/same color/similar colored teams play each other. Boyd to get quotes by next board meeting.

C. Changes to Website

1. Greg Curl needs to be added to board members/contacts on MYFC website.
2. Suggestion of posting practice times on the MYFC homepage.

D. Scholarships

1. \$1,925.00 check received from Eddie Lagrone with Creek Nation to cover 4 specific cheerleaders and 9 specific football players. Possibility of 4 more kids being chosen to be covered, waiting on approval from Creek Nation.

E. Fundraiser's Report

1. *Papa Murphy's Cards*- 400 purchased, 110 still outstanding.

F. Advertising

1. Karen to create a form to go with advertising letter, for Business owners to fill out when ordering packets.

G. New Business

1. *Fees for Board Members children*- Section 4.09 states we are allowed to participate in fundraisers, but in no way able to give special privileges to board members children by waiving or reducing their fee. We are also in the business of becoming a Non-Profit Organization and doing so would be inappropriate.
2. *Mypro's Tourney*- MYFC to organize our own tournament not associated with Mypro's, to be held annually after the playoffs. We will be going head to head with the Mypro league and their tournament. Suggested getting a packet together about the tournament.

Dan Hall Motion to go head to head with the Mypro's tournament, Nov. 14th Sunday to Sunday, 3rd thru 7th grade, \$20 per kid up to 25 kids then \$30 thereafter, called the OKIE CLASSIC. 2nd by Boyd Jones, all approved none opposed.

Open Issues

- Greg suggested having an "Old School Classic" as an end of the year fundraiser.
- Briefly discussed possibly getting the pads out to the players before the 1st practice on August 2nd, and shuffling the Pads camp behind the Combine camp.
- **2 Cheer Camps to be held July 12th-16th for 7th graders and July 19th-23rd for 1st thru 6th grades. Cost for each camp is \$50.00 and each girl will receive a shirt and practice shorts at the camp. Both camps will be held at Muskogee High School's practice gym.**
- Discussed having a few available board members at the opening days of Summer Pride to appeal to more 6th & 7th graders who may not know there will not be 7th grade football in middle school any longer.
- Discussion of implementing an "early bird fee" of \$100.00 for those who register & pay for their kids season in advance, the last 2 weeks of the current season. The fees would then be \$125.00 from end of season until June 15th, then \$150.00 from June 16th on.
